## **Future Research Interests**

Buddhist Metaphysics and Mental Health

*Background*: This would resume my honours-level work, based on personal experience, about how developing an understanding of key concepts in Buddhist metaphysics can assist in becoming free from drug and alcohol addiction, in better managing ADHD and in overcoming subsequent regret.

• Conservative Analysis of the Proposed Codification of the Principles of the Treaty of Waitangi (underway)

*Background*: New Zealand's Parliament will soon consider a proposal to codify principles of the Treaty of Waitangi 1840, one of New Zealand's founding documents, which have evolved under the common law since the 1970s. My preliminary analysis, supported by a grant by the Manukau Urban Māori Authority, suggests that one particular Parliament substituting its judgment on this matter over what has evolved discursively over decades would be radical not conservative.

Conservative Perspective on Taniwha Ontology (underway)

*Background:* Taniwha are supranatural entities in the Māori tradition but are not well-known or accepted by the dominant tradition of the New Zealand state. A public debate in 2011 on how the New Zealand state should accommodate the interests of taniwha, on which I provided paid public-relations advice to Auckland Council's Independent Māori Statutory Board, has helped spark an academic debate which may benefit from a conservative perspective.

• Conservative Response to Singer's Drowning Children

Concept: This would seek to apply conservative principles to argue why it is utterly morally obligatory to save a child in one's immediate spatiotemporal region but not similarly morally obligatory to mitigate suffering in other spatiotemporal regions. This may help the effective altruism movement avoid some of its more extreme and controversial positions.

• Conservative Response to Reckless But Legal Military Orders

Concept: This would consider what conservative principles suggest about how the military leadership of great powers ought to manage orders from their civilian commanders-in-chief that, while technically legal, are very much outside the bounds of what has been contemplated previously, and which clearly carry costs and risks far exceeding any apprehendable strategic benefits.

Conservative Response to Hypothetical Russian Invasion of Estonia's Ida-Viru County

Concept: This would consider what conservative principles suggest about how civilian and military leaders in Nato countries should respond to a Russian invasion and occupation of Estonia, if limited to its small but energy-rich eastern Ida-Viru county, with a majority Russian and Russian-speaking population.

Post-Trump Conservatism: Return to Pre-9/11 Bush?

Concept: This would consider whether the "compassionate conservatism" of George W Bush, including his preferred "humble" foreign policy which did not survive the 9/11 attacks, might be a useful starting point for conservatives to begin rebuilding their movement in the post-Trump era.

• Conservative Analysis of Disastrous Decisions by NZ Businesses in Australia

Concept: Otherwise globally successful New Zealand businesses haven a poor record investing in or expending their operations to Australia. This research idea is to consider what conservative principles suggest about how investors, governance and management should have analysed various proposals, including the disastrous 2001 takeover of Ansett Australia by Air New Zealand, and other infamous misadventures by New Zealand businesses in Australia. This may assist such debacles from being repeated.
